THE POLICY

The Salt Lake City School District Board of Education recognizes the importance of having a clear process for addressing employee and employment related issues. Although there are many internal policies, procedures, and rules, employees are expected to comply with all internal requirements as well as all applicable federal, state, and local laws, regulations, and administrative rules. District supervisors and administrators have the authority to make appropriate disciplinary decisions with regard to employees, except when that authority is limited by a formal written employee agreement. When appropriate, the district will utilize a system of progressive discipline to address situations where an employee has demonstrated unacceptable conduct and/or performance. Employees may be disciplined by suspension, demotion, termination, or any other action deemed appropriate under the circumstances. All disciplinary action will be implemented in a reasonable, fair, and consistent manner in accordance with all applicable laws, rules and policies.

The purpose of this policy is to notify employees of the district's authority to discipline and to protect the rights of employees. This policy does not in any way alter at-will employment relationships.

The district has set forth its specific processes for implementing this board policy through the accompanying <u>administrative</u> <u>procedures</u>.

No district employee or student shall be subjected to discrimination in employment or any district program or activity on the basis of age, color, disability, gender, gender identity, genetic information, national origin, pregnancy, race, religion, sex, sexual orientation, or veteran status. The district is committed to providing equal access and equal opportunity in its programs, services and employment including its policies, complaint processes, program accessibility, district facilities for all youth groups listed in Title 36 of the United States Code, including scouting groups.
